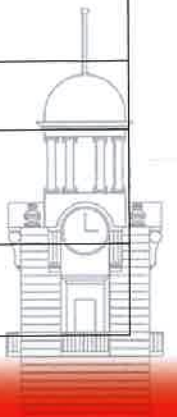

理事会选举的有关章程节录于下:

- 5.1: 永久会员在会员大会有投票权, 有权参加理事会选举和担任职位。
- 9.1: 理事会为本会管理机构, 拥有三十名理事, 于每隔三年的会员大会选举时选出 (以下简称选举)。
- 9.3: 合格的会员可以参加选举。提名表格须由候选人、提名人及附议人签名, 并于选举年常大召开前至少 30 天送达选举委员会, 方为有效。每名会员最多可提名二名候选人参加选举。
- 9.4: 选举委员会须于选举年常大召开前至少 21 天将候选人名单张贴于本会布告栏。
- 9.5: 若候选人数不超过三十名, 则所有候选人均自动当选为理事。
- 9.6: 若候选人数超过三十名, 选举委员会须于选举年常大召开前至少 14 天将选举表格 (简称选票) 连同候选人名单邮寄给会员在新加坡的地址以便投选。

Below are extracts from Alumni's Constitution, pertaining to council election matters:

- 5.1: Life Members can vote at general meetings, stand for election and hold office.
- 9.1: The Council is the governing body of the Association. It consists of thirty members. The election of the Council (hereinafter referred to as "the Election") shall be held every three years at AGM.
- 9.3: Only eligible members can stand for election. Every nomination must be made on the prescribed form and must be signed by the candidate to signify his eligibility and willingness to accept office, and by the two members who proposed and seconded the nomination. The duly completed form should be submitted to reach the Election Committee at least 30 days before the AGM. Each member shall be entitled to nominate up to two candidates for the election.
- 9.4: The Election Committee shall post the names of the candidates on the notice board of the Association at least 21 days before the AGM
- 9.5: If not more than thirty candidates are nominated for the Election, the candidates shall be deemed to be elected to the Council and they shall co-opt such number of other members as are needed to fill the remaining vacancies at the first Council meeting. The members so co-opted shall serve on the Council and shall have the same power and term of office as the elected Council members.
